Pursuant to the legal requirements relating to principles and procedures of application to data controllers, you, as a data subject, are required to provide in your application your name and surname, your signature if it is submitted physically, your Turkish ID if you are a citizen of Republic of Turkey, your nationality and passport (if any ID) number if you are a foreigner, your notification address or company address, your e-mail address and fax number for notification purposes, and a detailed explanation of the request. In addition, you are required to submit proofs of your ID as well as other information and documents relating to your request along with your application.
